NEW BUSINESS:

Injury Reports – Jennifer Keating reported that the District is in good standing. There are a few old claims that are still open.

Email Reports – The Committee had received several emails as follows:

- Middle School Principal Jennifer Bradley concerned about the phone in the Middle School cafeteria. No one can hear it when it rings. This is a problem when the office is trying to reach her in the cafeteria. Brian Seaman reported that he spoke to Mrs. Bradley and she can carry the radio with her and the office will be able to reach her and the SPR's through the radio. This phone was placed in there for getting help in case of an emergency.
- High School Teacher Mark Nebzydoski reported that room 812 has an eye wash station that has not been functional for some time. The old eye wash station was leaking and the water needed to be shut off to both the eye wash and safety shower. Dave Robinson reported that a new eye wash station was ordered and that the custodial department hadn't had time to install it.

Other:

At this time, the Committee conducted a tour of the EverGreen Elementary School.

EverGreen custodian Adam Lanza approached the Committee with a concern about the ladder on the garden rooftop. He suggested a permanent ladder with a cage be installed. Paul Gregorski asked Mr. Lanza to please email the Committee so we can look into this situation. One issue was found concerning the door leading out on to the roof top garden. Towels were placed at the bottom of the door to prevent water from coming in due to poor drainage. The water runs under the door and onto the upstairs floor which then leaks down through the ceiling. Discussion was held concerning some sort of door seal and possibly extending the drain pipe further so it does not drain onto the rooftop and under the door. The EverGreen School was clean, organized, and in good condition.
