# Board Minutes December 1, 2021

The regular monthly meeting of the Western Wayne Board of Education was held on December 1, 2021 at the District Office and via Zoom.

The meeting was advertised in the legal section of the November 18, 2021 edition of the Tri-County Independent.

President Rick Hoch called the meeting to order at 6:39 P.M.

Mr. Hoch offered a prayer followed by the Pledge of Allegiance.

Dr. LaRosa also thanked members of the Hideout Community for their generous donations to our students this holiday season.

High School Principal, Mr. Gregorski, introduced two outstanding students Alexandria Bien-Aime and Rachel Hoch. Each student shared a video with the Board of Education. Mr. Gregorski congratulated the students and thanked their parents. Mr. Hoch also congratulated the students and noted that Rachel is his youngest daughter and he has had students in the Western Wayne School District for the last 21 years.

#### 11. Recognition of Public - 15 minutes

Christina Hinz told the Board that she is disappointed in them and mad that we do not have in person meetings. She stands with hundreds of parents asking to allow parents to make the best decisions for their children. She wanted to know if we are going to require vaccines and the unvaccinated to mask? She is hopeful masking will be lifted on December 8<sup>th</sup> with the court decision. She does not want to pull kids, but she will. Dr. Barrett stated that many of her questions could not be answered at this time. We are following the law and there is no current mandate for vaccines that is not currently on the table.

Dr. Amanda Johnson stated she is glad concerts and sports are back for the winter, she also thinks Penn College is a great opportunity. She noted there were no printed copies of the agenda and we are violating her constitutional right to assemble. Why are we still Zooming our meetings, why not in person? Dr. Barrett stated we have worked with our Solicitor and received guidance from PSBA on how to conduct virtual meetings. COVID numbers are in high category of transmission at the county level and we have had incidents at past meetings.

Robert Hess said he agrees with Mrs. Hinz about masks. He believes COVID has zero effect on children, how many children have died? Mr. Hoch stated it is more than just the children, we have staff and families to consider also. Mr. Hoch stated we will continue to follow the mandates as voted on for the last several meetings. Mr. Hess stated that Western Wayne's Health and Safety plan should be revised immediately. He hopes the board can educate themselves instead of fear mongering and put the mask wearing charade to the side.
