President Rick Hoch called the meeting to order at 6:03 P.M.

Mr. Hoch offered a prayer followed by the Pledge of Allegiance.

High School Principal Mr. Gregorski introduced two outstanding students Sarah Collins, who was present and spoke about her accomplishments and Kennedy Mistishin who shared a video of her accomplishments with the Board of Education. Mr. Gregorski and Mr. Hoch thanked the students and their families.

c. Staff Recognition

1. Law Enforcement Recognition – SPO's

Assistant To Superintendent Dr. LaRosa spoke in regards to January 9th is Law Enforcement Recognition Day. We would like to publicly recognize and thank our School Police Officers. The primary goal of the school police officer is to assist school administration in maintaining a safe and secure environment, and we are so thankful for their willingness to go above and beyond to support our Wildcat Family.

Our School Police Officers provide a welcoming presence during arrival and departure. Their presence is equally important inside our buildings, where this group of gentlemen are frequently walking the halls, stopping into lunches, and speaking with faculty and staff.

So tonight, on behalf of the Board of Education and the Western Wayne Administrative team, we would like to thank Officer Paul Semler, Officer Marty Robbins, Officer Wayne Thomas, and Officer Danny Martin for their service and dedication to our students, faculty, staff, and community members.

2. Elaine Ort, Band Director

Dr. LaRosa recognized Band Director, Mrs. Elaine Ort. On January 1st, Mrs. Ort joined band directors from across the country to perform in the annual Pasadena Tournament of Roses Rose Parade. The parade entry conveyed the theme, *"We teach music. We teach life."*

This theme reflects Mrs. Ort's passion for music education. Since 2014, she has served as Director of Instrumental Ativities at Western Wayne School District - teaching 6th grade brass, 8th grade band, and the Pride of Western Wayne, the Wildcat High School Band. Under her direction and guidance, the music program was recently named a KHS America Academic Alliance Platinum school for its investment in instrumental education. It is the only school in Pennsylvania, and one of only 39 in the United States to have received that honor.

Congratulations, Mrs. Ort, on your accomplishments and for representing Western Wayne on a national level!

10. Recognition of Public - 15 minutes

Kim Butler stated she sent emails to the Board of Education regarding agenda item #19b - the WWESPA MOU. She feels \$2 per hour is not enough and she urges the Board to vote no, the Board can do better. The food service staff works hard and deserves more.

Tanya Klippel stated her children are in private school because of masks. She thinks the number of children with severe cases of COVID are low and we are lessening our children's immune systems by making them wear masks.

Jeremy Edwards asked if we will lose funding if we do not mask our students. What does benefits mean in the ESSER Grant agreement? Miss Emmett said they are social security, Medicare, and Worker's compensation. How much are we spending on Tremco and other construction with the ESSER Funds? Dr. Barrett said around \$500,000 for safety and security items. He urges the Board to take masks off our kids.

Christina Hinz feels we keep pushing the mask mandate into the future. When will it be optional? Dr. Barrett stated that the revised health and safety plan that is on the agenda tonight will allow for mask optional times provided certain percentages of staff/student positivity rates are below a certain number per building. She also wanted to urge the Board not to make a vaccine mandate. She understands we do not have one now, but wants it to stay that way. She also stated that Western Wayne has amazing teachers and staff who work hard, especially during these times.

Amanda Johnson spoke in protest to the agenda item about the Health and Safety plan. She feels it is a violation of the Sunshine Act to give the Superintendent the authority to review and revise the plan as needed. She asked the Board to oppose this motion.
