## **School Responsibilities**

The Robert D. Wilson Elementary School will:

  - a. Treating each child with dignity and respect
  - b. Striving to address the individual needs of each student
  - c. Uninterrupted classroom reading instruction using researched-based materials
  - d. 30 or more minutes of intervention instruction using researched-based materials in grades 1, 2, and 3
2. Ensure communication between teachers and parents on an ongoing basis by:
  - Holding parent-teacher conferences annually during which this compact will be discussed as it relates to the individual child's achievement. Specifically, those conferences will be held in the Fall of each school year or at any time a student becomes eligible for Title I services.
  - Providing frequent reports to parents on their child's progress. Specifically, the school will provide the following reports: Kindergarten-twice a year, Grades 1-5-four times a year, or at any time upon request.
  - Providing parents reasonable access to staff. The staff will be available for consultation with parents during the school day or anytime by appointment.
  - Providing parents opportunities to volunteer and participate in their child's class, and to observe classroom activities by appointment and with permission from the office and obtaining the necessary clearances. A District Visitation Policy is in place.
  - Ensuring regular, two-way meaningful communication between family members and school staff, and to the extent practicable, in a language that family members can understand.
3. Regard parents as partners in their children's education by:
  - Acknowledging that parents are vital to both the child's and the school's success.
  - Assuring that the school staff communicates clear expectations for performance to both students and parents.
