#### **Adoption of Proposed Preliminary Budget**

A motion was made by Mr. Olsommer and seconded by Mr. Hollister to adopt the 2015-2016 Fiscal Year Proposed Preliminary Budget showing estimated available resources of \$42,702,040 and estimated expenditures and ending fund balance in the amount of \$42,702,040 establishing real estate tax millage of 16.6720 with a 2% discount if the whole amount of the tax is paid within two months after the date of the tax notice; payment at face if the tax is paid within two months following the end of the discount period; penalty of 10% on all taxes not paid within four months after the date of the tax notice. This will be a 5.45% tax increase. (ATTACHMENT – I)

Mr. Gaudenzi stated that the tax increase is a big concern, he will not support it; Mr. Gershey stated that this is worst case scenario but not necessarily what will happen in June and need to consider it now; Mrs. Pliss stated that this is needed now as to not tie the business manager's hands in preparing the budget over the next few months. After several more minutes of discussion, the board voted as follows:

The motion failed with Mr. Hollister, Mr. Gershey and Mr. Olsommer voting in the affirmative and Mrs. Fiorella, Mr. Gaudenzi, Mr. Lindow, Mr. McDonough and Mrs. Pliss voting no.

### **Staffing**

A motion was made by Mrs. Pliss and seconded by Mr. Gershey to authorize the Superintendent to analyze professional staffing needs for 2015-2016 school year and to make recommendations to the Board related thereto.

#### Resolution

Mr. Lindow proposed a motion for the Board of Education to stay within the Act 1 Index for the 2015-2016 School Year.

The motion failed to get a second.

#### **Tax Rebate**

A motion was made by Mr. Gaudenzi and seconded by Mr. Olsommer to approve a Real Estate Tax Rebate in the amount of \$135.05 on property # 04-0-0242-0094- .L056K in Canaan Township. The rebate is due to the removal of a trailer.

The motion carried with all affirmatives.

#### **Tax Rebate**

A motion was made by Mrs. Fiorella and seconded by Mrs. Pliss to approve a Real Estate Tax Rebate in the amount of \$151.84 on property # 12-0-0293-0032.A002-L0199 in Lake Township. The rebate is due to the registration of a trailer.

Committed: \$0; Assigned: \$0; and Unassigned: \$844,451.

- d) Region Orchestra Scranton Cultural Center March 11-13, 2015. Chaperone: Elaine Ort 2 students (approximate). Cost: Student fees \$280.00; Meals/Hotel \$250.00; Director Extra pay \$166.11; Sub rate \$170.00. Total district cost \$990.00. (2 students/\$990.00 = \$495.00 cost per student).
- e) All State Band Hershey March 25-28, 2015. Chaperone: Elaine Ort 2 students (approximate). Cost: Student fees \$500.00; Meals/Hotel \$500.00; Director Extra Pay \$193.80; Sub rate \$255.00. Total district cost: \$1,642.00. (2 students/\$1,642.00 = \$821.00 cost per student).
- f) District Jazz Forest City/Scranton Cultural Center April 17-18, 2015. Chaperone: Elaine Ort 1 student (approximate). Cost: Student fee \$140.00; Director Extra pay \$55.37; Sub rate \$85.00. Total district cost: \$321.89. (1 student/\$321.89 = \$321.89 cost per student).

g) Marching Band Disney Trip – Disney World, Florida – April 22-25, 2015 – 86 students. Chaperone pay \$664.44 (students pay for all other costs). Chaperones: Elaine Ort, Jessica McLaughlin, Maria Arneil, Chuck Bayly, Harriet Bayly, Marty Ort, Marie Jellock, Angel Hutchins, Stacey Batzel, Warren Batzel, Greg Skirpan, Cindy Davis, Cindy Motichka, MaryAnn Curtis, Yvonne Berger, Arnie Berger, Noreen Ofner, Debbie Wilson. (86 students/\$664.44 = \$7.73 cost per student).

The Board discussed the need to stay overnight for local trips, it was stated that it was part of the experience. They discussed letting it be as stated for remainder of 14-15, but change practice for 15-16 and future years by not allowing overnights for local events.
