The regularly scheduled reorganizational meeting of the Western Wayne Board of Education was held on Monday, December 7, 2015 in the District Office located at 1970C Easton Turnpike, Lake Ariel PA.

The meeting was advertised in the legal section of the November 27, 2015 edition of the Wayne Independent.

Mr. Olsommer called the meeting to order at 6:01 P.M.

Miss Emmett took roll call. All nine (9) Board members were present and are listed as follows:

Oath of Office

Attorney Matthew Meagher administered the oath of office to the following new and returning board members: William Gershey, Jeffery Gogolski, Rick Hoch, Gary Enslin, and Roger Shaffer, Jr. After the oath was administered the new Board members took their seats with the rest of the Board Of Education.

Election of Temporary Chairman

Mr. Gershey nominated Mr. Olsommer to act as Temporary Chairman. Mr. Gogolski seconded that nomination. Hearing no other nominations, nominations were closed and Mr. Olsommer was voted as Temporary Chairman by a vote of eight affirmatives and one abstention from Mr. Shaffer.

Election of Board President

Mr. Gershey nominated Mr. Olsommer for President. Mr. Gogolski seconded that nomination. Mr. Shaffer nominated Mr. Gaudenzi for President. Mr. Enslin seconded that nomination. Hearing no other nominations, the nominations were closed. Mr. Gaudenzi stated he was honored to have the confidence of two new board members, accepts 100% and plans to disseminate information to the public and do what is best for

the students. He intends to provide the best education for the students by working with the Administration, staff and taxpayers. Mrs. Fiorella stated she will not be voting for Mr. Gaudenzi, she cannot vote for someone who does not vote to pay our employees, or support our contracts in support of our employees, therefore she will not be voting for him.

Mr. Olsommer was voted President by a roll call vote of five affirmative votes, while Mr. Gaudenzi received three affirmative votes. Mr. McDonough chose not to vote for either candidate.

Election of Board Vice President

Mr. Olsommer nominated Mr. Gershey for Vice President. Mr. Gogolski seconded that nomination. Mr. Shaffer nominated Mr. McDonough for Vice President. Mr. Enslin seconded that nomination. Hearing no other nominations, the nominations were closed.

Mr. Gershey was voted Vice President by a roll call vote of five affirmative votes, while Mr. McDonough received four affirmative votes.

Other

Mr. Gershey submitted his resignation as Treasurer being that he is now our Vice President. There were nine affirmatives to accept his resignation.

Mr. Gershey nominated Mr. Gogolski for Treasurer. Mr. Shaffer seconded that nomination. Hearing no other nominations, the nominations were closed.

Mr. Gogolski was voted Treasurer by a roll call vote of eight affirmative votes, while Mr. McDonough voted no.

Adjournment

A motion was made by Mr. Gershey and seconded by Mr. McDonough to adjourn the regular scheduled reorganizational meeting of the Western Wayne Board of Education at 6:21 P.M.

The motion carried with all affirmatives.
